8:24 Policy – Fiduciary Responsibilities

- Follow-Up to Congregational Vote: Pr. Varinia will be coming to St. Louis on Wednesday to house hunt/drop off books. She will move here by the end of August, and start working September 6th.
- Financial Update by Troy Larson, Contributions were down in June, although that is typical for summer.
- Preparing for 2023 Budget: Starting to prepare/think about it
- Retreat Dates and Proposed Approach: This year we don't need the Retreat as much for Strategy, as we are doing this during the monthly Council Meeting. We will be working on the second day by including the leader of each team to join us for volunteer training. The afternoon will have ministries and committees consider and plan how they can advance our priority areas.
- HVAC Updates: Another contract for connecting the old system to the new install. Looking at August 11 for the install. FMPC/Track Lighting: Tracks and lighting were state of the art when it was installed. Currently some are no longer working, and we now need LED lighting. Bid was for around \$13,000, with total being less than \$20,000. Funding will be checked into, to see where there are available funds. As a vote for approval is needed by the end of the month. Thus, a motion was made to pass the contract for funding for the LED Track Lighting by Larissa Hautekeete, seconded by Gene Unverfehrt, and passed Unanimously, if funds are identified and available. UPDATE: Since the July 18th meeting, required funding was secured, and the team was notified of Council Approval.

There will be an upcoming meeting to see if we might qualify for the second round of the PPP.
