- 4. Feed the Need STL Board: Eric Hilleman has agreed to be our official liaison on the Feed the Need STL Board. A motion to accept this nomination was made by Lanny Schnipper and seconded by Greg Mueller. Motion was approved unanimously.
- 5. Asset Development Team will be appointed and will look at having some focus groups.
